The District Director is responsible to mail the yellow copy to the State Chairman before the first tournament game. The white copy will be carried by the manager of the tournament team and must be presented to the Tournament Director of each tournament along with the birth records of each player. All corrections must be made on all copies of affidavits before they are mailed to the State Chairman.
 District Directors failing to mail copies of affidavits to the State Chairman prior to sub-district may eliminate all teams from competition.
